#### 4. Communications Report – Susan

Susan reported that no new Swimspirations have been submitted lately.

#### 5. Financial Report – Keith

We are about 87% of budgeted registration revenues for the year. A detailed financial statement is on file in the Secretary's binder.

#### 6. Vancouver Foundation Discussion

A reminder that our original \$20,000 contribution to the Vancouver Foundation is a 'gift', not an investment. We want the future cash flow it will create, not the \$20,000. This 'gift' contribution keeps us safe for the future as the return is so much higher than through bank GICs.

At the AGM, the members will be asked:

**MOTION**: Does the Board have permission to donate an irrevocable gift of \$50,000 to the MSABC Endowment Fund at the Vancouver Foundation? Susan seconded. 2 opposed. Remainder in favor. Motion carried.

**ACTION**: John will make a presentation at the AGM.

In short, the main 'con' to this gifting is that the money is gone. The main 'pro' is that MSABC receives 2-3 % more interest each year than if invested in a GIC.

If the members are not comfortable with the \$50,000 donation, then the vote can be amended.
